WHEREAS, the International Labor Organization recognizes there are an estimated 40.3 million people in modern slavery globally where 1 in 4 victims are children; and

WHEREAS, the National Center for Missing and Exploited Children estimates one out of six endangered runaways were likely child sex trafficking victims; and

WHEREAS, the U.S. Department of Labor identified 139 goods from 75 countries made by forced and child labor; and

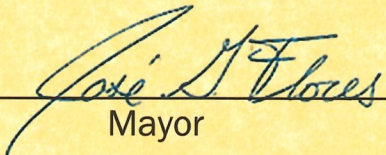
WHEREAS, the City of Clovis recognizes the need for greater awareness and accountability in regard to modern-day slavery.

1. Form the committee.
2. The makeup of the committee would be 25 members with each Council Member nominating 5 members each.
3. The scope of the Committee analysis would be staffing of the entire Police Department.
4. Review and report expenditures and staffing within the Police Department over the past fifteen years.
5. Consider what it is going to take to stay the "Safest City in the Valley".
6. Report back on the required timeline should a tax measure be considered to be placed on the November 2022 ballot.

Staff requested further clarification on three items from the November 15, 2021, meeting as follows:

1. What is the consensus of Council participation on the committee? Consensus of Council to allow City Council participation in Committee meetings.
2. Unclear if Committee members would be required to live / work / own property in the City. Consensus of Council to require Committee members live, work, or own property in the City of Clovis.
3. Council indicated they were interested in having members of the general public involved in the process, outside of the selected committee members. Consensus of the Council for public to participate in the Committee meetings as well as town hall meetings after the Committee is concluded.

17B. APPROVED OPTIONS REGARDING FACILITATING THE 25 MEMBER COMMITTEE MEETINGS THROUGH THE PROCESS;

Don W., resident, commented on allowing the committee to independently choose a Chair and Vice Chair with no facilitator and a limit of 15 committee members.

It was the consensus of City Council for the Mayor to choose a Chair and Vice Chair from the Committee members to act as a facilitator for the Committee.

Currently the Administration Department is authorized for one (1) Housing Program Coordinator position. It is recommended that the City's Position Allocation Plan be amended to add one (1) Management Analyst position and delete (1) Housing Program Coordinator position. Council approval is required for changes to the Position Allocation Plan.

BACKGROUND

The Administration Department has recently evaluated the work assignments and needs in the department and has determined that the addition of one (1) Management Analyst position and deletion of one (1) Housing Program Coordinator position will more efficiently support the current needs of the department. Following an unsuccessful recruitment for Housing Program Coordinator, it was decided that the management level position of Management Analyst would improve the hiring pool and allow for more qualified and higher educated candidates. The desired position allocation change results in the need to modify the City's Position Allocation Plan which requires Council approval.

FISCAL IMPACT

The fiscal impact of salary and benefits for the remainder of FY 21-22 is approximately an additional \$2,000. There are adequate funds in the Administration Department budget to cover the costs of the position.

REASON FOR RECOMMENDATION

The addition of one (1) Management Analyst position and the elimination of one (1) Housing Program Coordinator position will provide a more qualified candidate pool and better support the current staffing needs of the Administration Department. EXECUTIVE SUMMARY

On behalf of Victor Vidrio, III (claimant), a General Liability Claim against the City of Clovis was filed on December 17, 2021, regarding the allegation that the City caused a dangerous condition by failure to warn drivers of road construction ahead. Mr. Vidrio claims that he sustained bodily injuries and seeks reimbursement for medical expenses. It is recommended that the claim be rejected at this time.

BACKGROUND

On December 17, 2021, a General Liability Claim was filed against the City of Clovis on behalf of Victor Vidrio, III. The claim was considered legally sufficient and timely. Mr. Vidrio alleged that on July 28, 2021, the City of Clovis caused a dangerous condition by failure to guard, protect and warn drivers of roadway construction. Mr. Vidrio sustained bodily injuries from the accident.

Mr. Vidrio seeks damages for his medical expenses, and pain and suffering in an amount in excess of \$25,000. The claim has been filed as a “civil unlimited case”.

FISCAL IMPACT

Rejection of the claim does not result in any fiscal impact.

REASON FOR RECOMMENDATION

It is recommended that the claim be rejected. The City is not liable for this claim. In addition, by rejecting this claim, the time in which lawsuits may be filed against the City will begin to run.

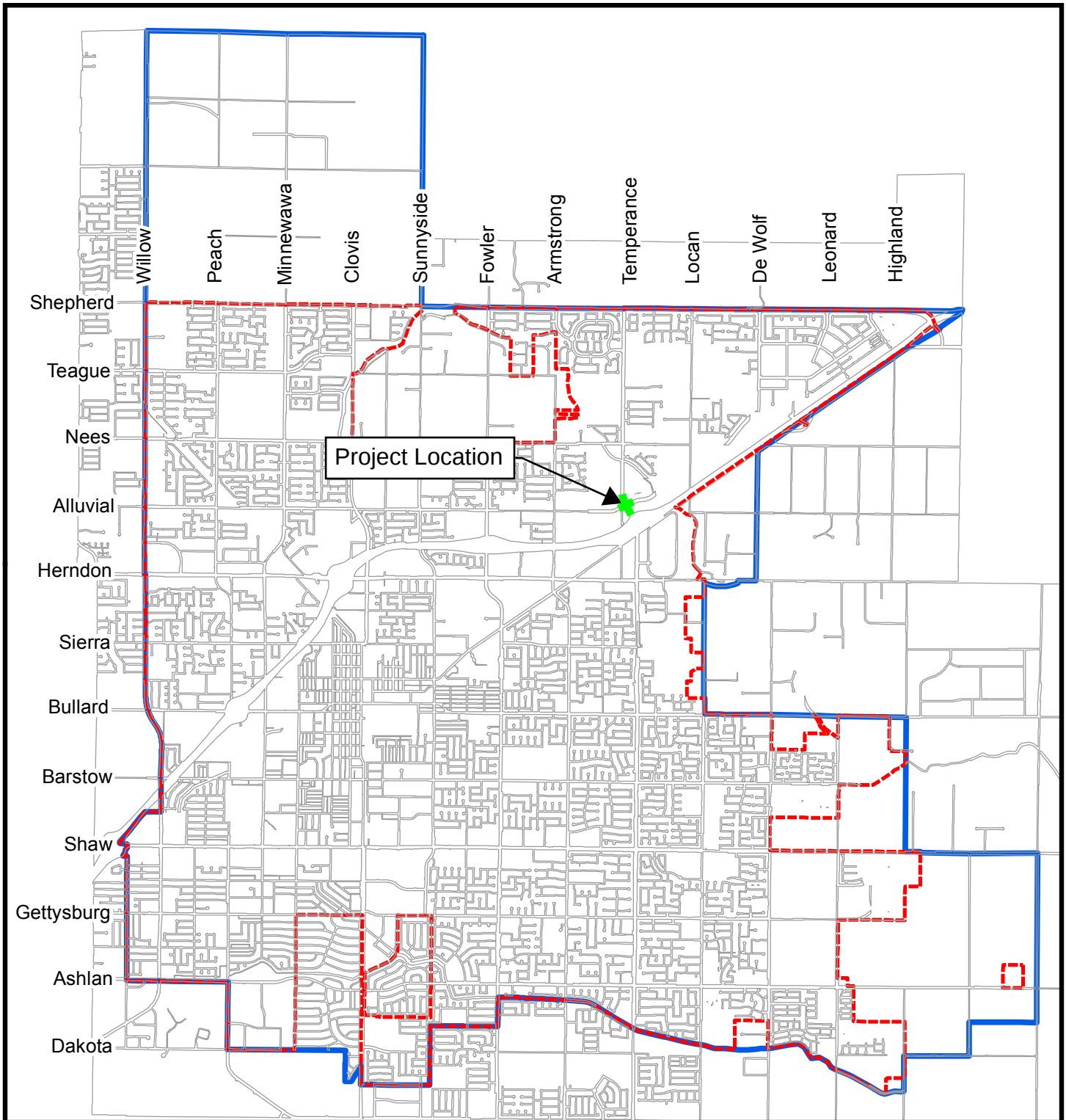

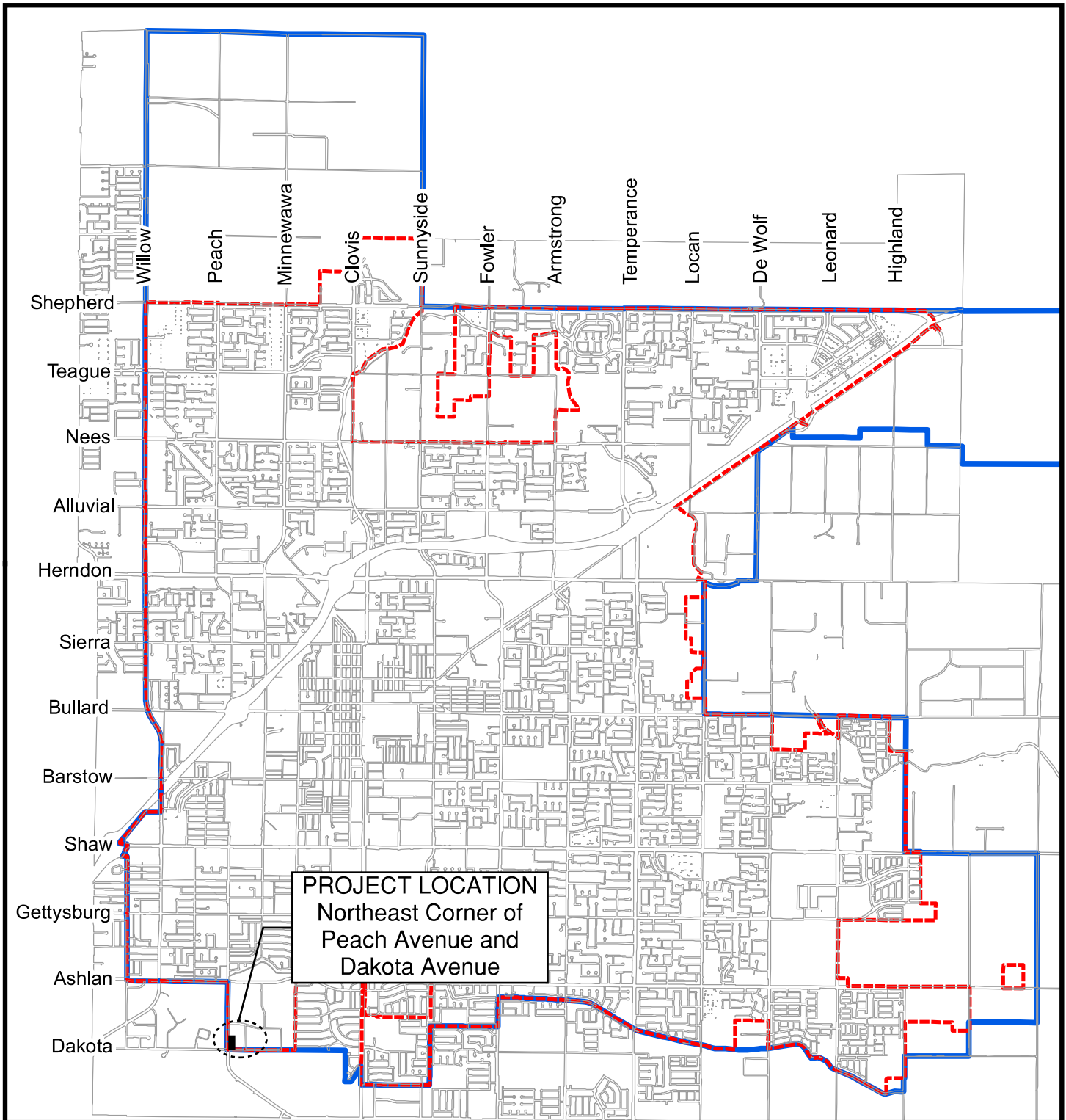

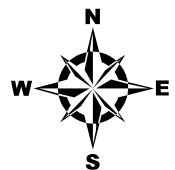

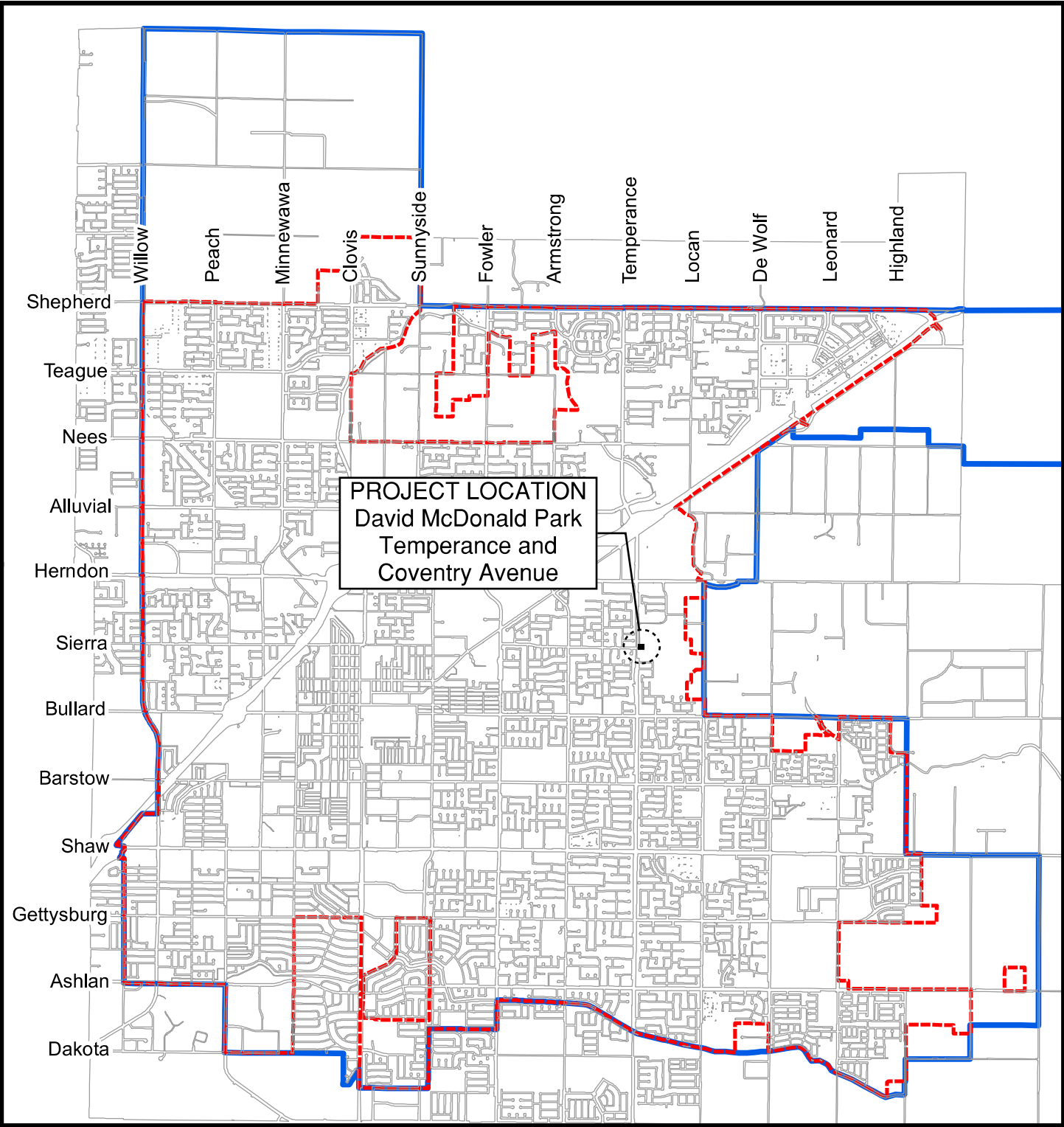

VICINITY MAP

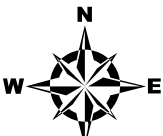
CIP 21-08 Sierra Meadows Monument Sign

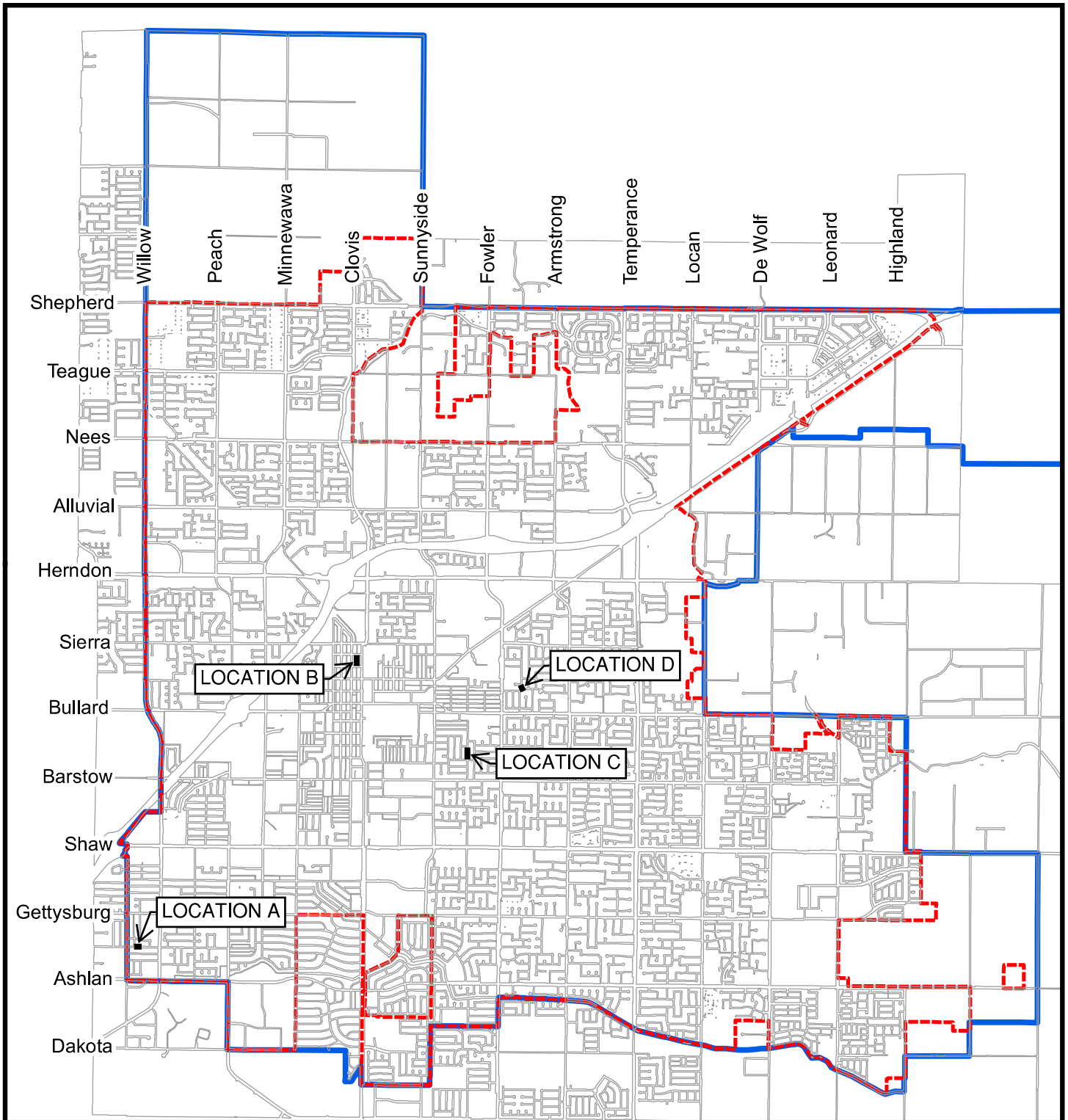

EXECUTIVE SUMMARY

Staff is recommending that City Council approve a resolution amending the CIP budget for the Modular Training Facility Project and authorize the City Manager to award and execute the contract to Fortune-Ratliff General Contractors, Inc., who was the lowest responsible bidder from a bid opening that took place on December 14, 2021.

The project consists of the construction of a Modular Training Facility Building located at the northeast corner of Lind Avenue and Pontiac Way. This building will initially be used to temporarily house the crew for Fire Station 2 while the Fire Station 2 building is in the process of being reconstructed on its existing site. Once the new Fire Station 2 building is complete and the Fire Station 2 crew moves out of the modular building, the modular building will be modified to be used as a training facility. The existing Fire Station 2 building condition is degrading rapidly

and is in need of costly maintenance that is difficult to postpone much longer. To avoid this additional maintenance cost, the Fire Station 2 reconstruction project needs to start as soon as possible. The modular building project timing is vital to keep the Fire Station 2 reconstruction project on schedule and to provide a location for the crew in the southwest area during reconstruction of Fire Station 2.

BACKGROUND

The following is a summary of the bid results of December 14, 2021:

BIDDERS

Fortune-Ratliff General Contractors, Inc.

BASE BIDS

\$2,342,502.00

ENGINEER'S ESTIMATE

\$1,251,000.00

All bids were examined, and the bidder's submittals were found to be in order with Fortune-Ratliff General Contractors, Inc. as the lowest responsible bidder. Staff has validated the lowest bidder's contractor license status.

After the bid opening, the City's consultant, Vanir, made inquiries with prospective bidders to find out why they did not submit bids. Initially, there were about 6 modular building companies that had shown interest in the project. Staff expected to have multiple bids submitted on the project, and the one bid submitted had the modular company as a subcontractor instead of a prime contractor. Of the modular companies contacted, one stated they could not meet the timeline laid out in the specifications due to their current workload. A couple of the other companies stated they assumed there were too many bidders, so they decided not to submit. Vanir also contacted the modular company included as the subcontractor for the bid submitted, and they confirmed they are able to meet the construction timelines and they have the materials needed for the building construction.

Engineering staff, the Fire Chief, and Administration discussed alternatives to awarding the project since the bid received is over one million dollars more than the estimate:

- The first option is to cancel the project entirely and temporarily house the Fire Station crew at an alternative location during the Fire Station 2 reconstruction. It was decided that the alternative locations for this option, one of which being Fire Station 1, would increase emergency call times in the southeast area to a point that would not be satisfactory.
- The second option would be not to award the bid received and rebid the project with a hope of more favorable bids. To do this staff would need to make modifications to the project plans and specifications prior to rebidding. It was decided that this option would not guarantee lower bids and it would keep the crew for Fire Station 2 in a building that has major maintenance issues for multiple months longer as we go through the bidding process again. As construction costs increase on a monthly basis, this could also increase the construction cost of Fire Station 2 with the delay.

- The final option of awarding the bid was decided upon as the best option. It will still allow the Fire Station crew to be located in the southwest area during reconstruction of Fire Station 2. It will also allow the Fire Station 2 project to stay on the current schedule.

FISCAL IMPACT

This project was budgeted in the 2021-2022 Community Investment Program. The project is funded by the General Services Fund through the City Community Investment Program. The original budget for the Modular Training Facility project was \$2 million with the assumption of the engineers estimate for construction. Modifications have been made to the budget estimate including the bid amount received for a revised budget amount of \$3 million. The increase to the budget for this project could impact the timing of potential future projects funded by the General Services Fund.

REASON FOR RECOMMENDATION

Fortune-Ratliff General Contractors, Inc. is the lowest responsible bidder. The Budget Amendment is needed to financially account for the additional expenditures in the General Fund.

ACTIONS FOLLOWING APPROVAL

1. Funds will be appropriated and accounted for in the City of Clovis 2021-2022 Budget as specified in the attached budget amendment.
2. The contract will be prepared and executed, subject to the Contractor providing performance security that is satisfactory to the City.
3. Construction will begin approximately one (1) week after contract execution and be completed in two hundred sixty (260) calendar days thereafter.

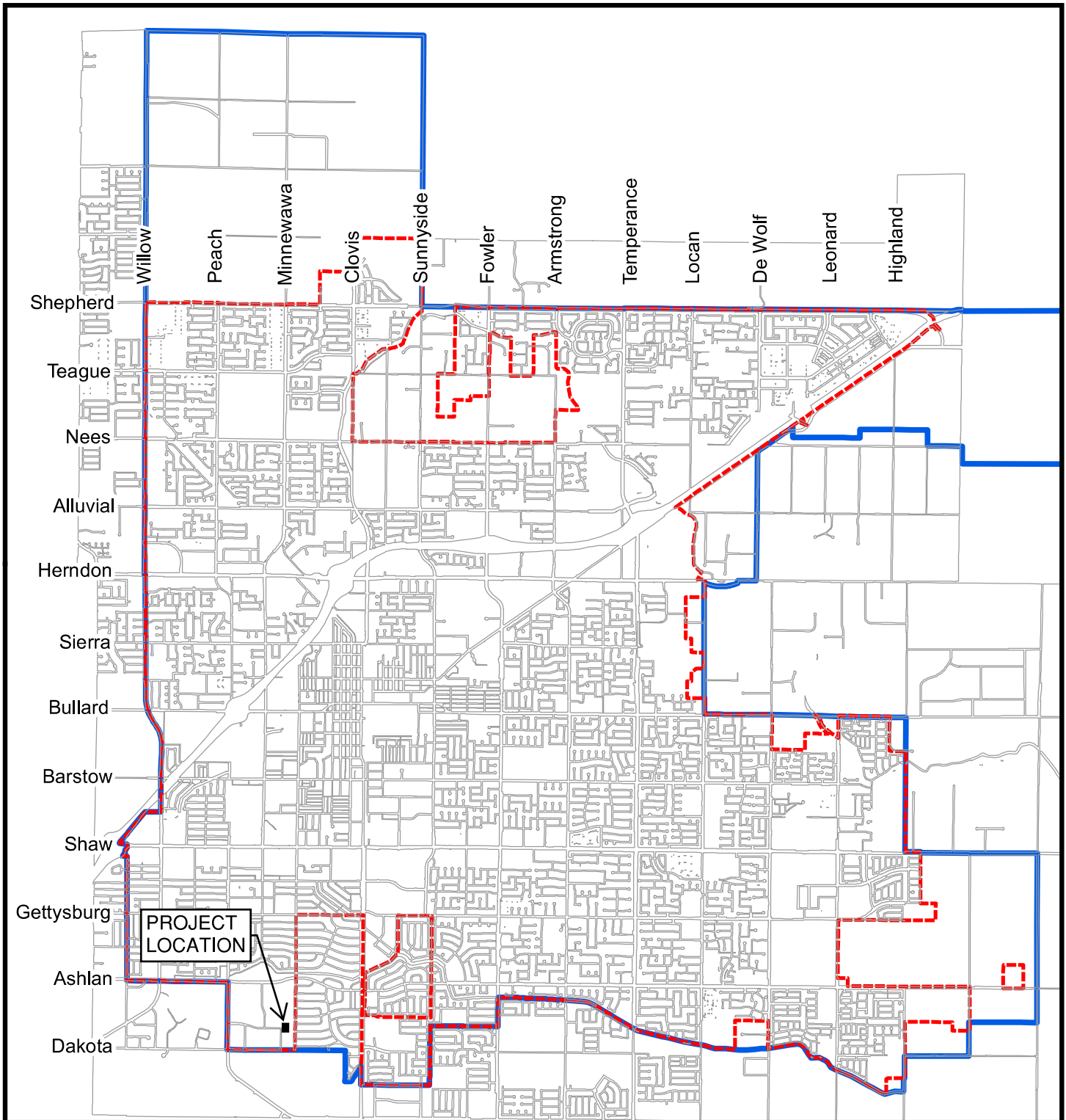

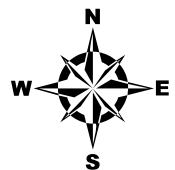

1. For the City Council to award a contract for CIP 19-08, Traffic Signal Pedestrian Modifications, to St. Frances Electric Company, Inc. in the amount of \$492,875; and
2. For the City Council to authorize the City Manager to execute the contract on behalf of the City.

EXECUTIVE SUMMARY

Staff is recommending that City Council award a contract and authorize the City Manager to execute the contract to St. Francis Electric, Inc., who was the lowest responsible bidder from a bid opening that took place on December 7, 2021.

This project will modify 28 traffic signalized intersections within the City of Clovis to upgrade the pedestrian signal equipment (see vicinity map). These 28 intersections were selected because they did not have Accessible Pedestrian System (APS) equipment, and they were 100% within the operation and maintenance jurisdiction of the City of Clovis. The project includes upgrading the existing pedestrian push button stations with audible accessible pedestrian push buttons stations. In addition, the incandescent pedestrian signal indications will be replaced with LED countdown pedestrian signal modules.

BACKGROUND

The following is a summary of the bid results of December 7, 2021:

All bids were examined, and the bidder's submittals were found to be in order with St. Frances Electric, Inc. as the lowest responsible bidder. Staff has validated the lowest bidder contractor's license status. After review of the bids, staff determined that even though the bids are more than 30% over the estimate, they are close to each other and represent the current cost increases in the market. St. Frances Electric was contacted regarding its bid cost for various equipment bid items. They indicated that the increased prices for equipment are primarily caused by the Covid-19 Virus situation. Suppliers are burdened with material shortages and reduced staffing, therefore there is an expectation of increased material cost and delivery delays. Since these Covid-caused conditions are not expected to subside in the near future and the low bids received were comparatively similar, staff believes that re-bidding this project would not produce substantially lower bid results.

FISCAL IMPACT

This project was included in the 2021-2022 fiscal year budget. The project is funded by the street fund and Highway Safety Improvement Program (HSIP) grant funding. Staff has requested additional HSIP funding for the difference between the engineers estimate and the low bid. If the request for additional HSIP funding is denied, gas tax or Measure C funds will be used for the difference.

REASON FOR RECOMMENDATION

St. Frances Electric, Inc. is the lowest responsible bidder. There are sufficient funds available to complete the project.

ACTIONS FOLLOWING APPROVAL

1. The contract will be prepared and executed, subject to the Contractor providing performance security that is satisfactory to the City.
2. Construction will begin approximately two (2) weeks after contract execution and shall be completed in Forty (40) working days thereafter.

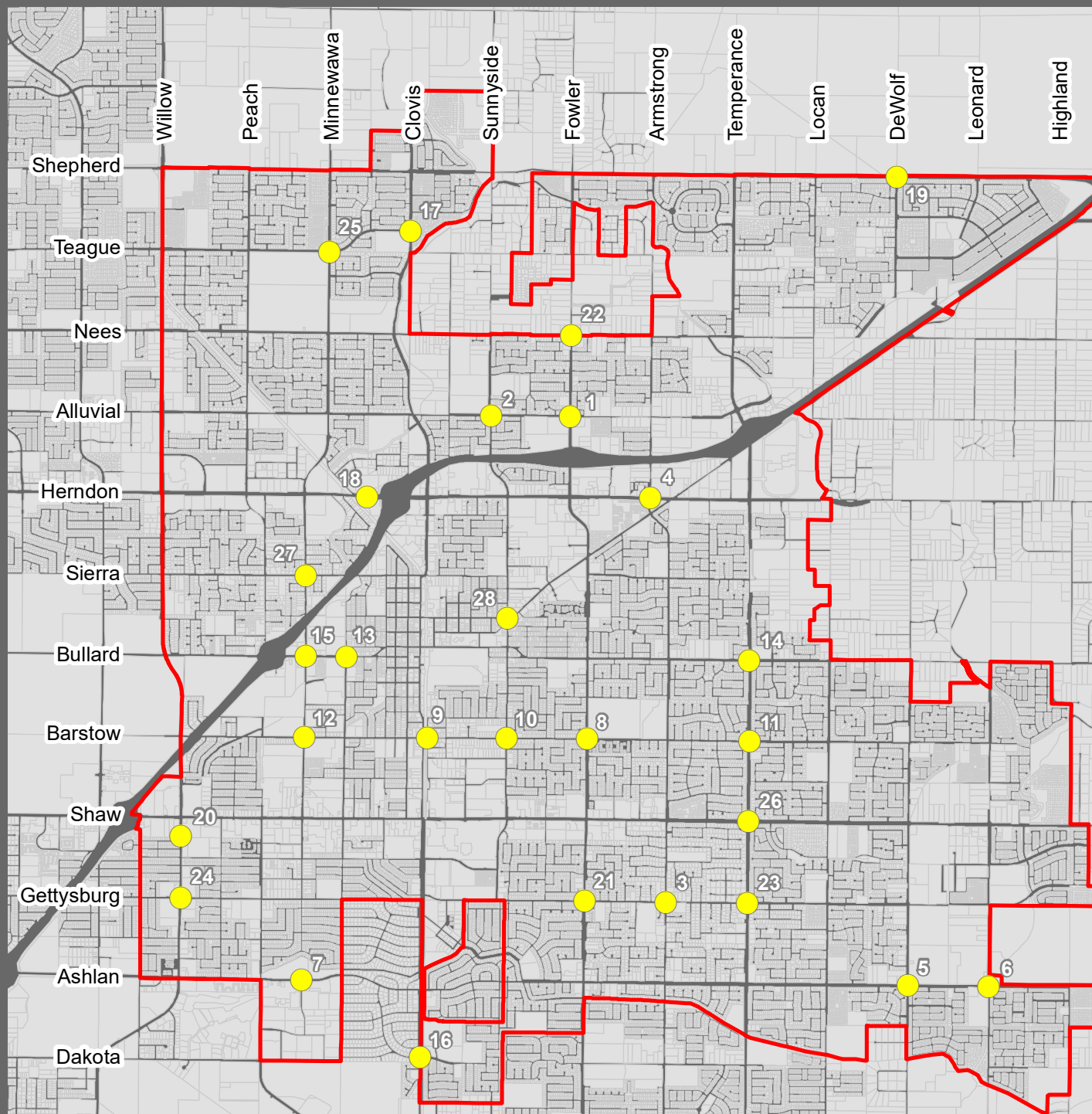

RECOMMENDATION

Staff recommends that the City Council consider the City's participation in the Fresno Council of Government's (FCOG) multi-jurisdictional housing element in a limited capacity utilizing certain defined regional analyses and data components, such as the housing needs assessment and fair housing assessment. Meanwhile, the City would continue to prepare and adopt its own independent housing element that incorporates the regional assessments. If partial participation in the multi-jurisdictional housing element is infeasible, the City should continue to pursue an independent housing element update.

EXECUTIVE SUMMARY

The City of Clovis, along with other participating cities and the County of Fresno, is currently engaged in the Regional Housing Needs Allocation (RHNA) Subcommittee process for the sixth cycle housing element update that is mediated by the FCOG staff and their consulting team. FCOG and member jurisdictions are also considering the potential for initiating a multi-jurisdictional housing element for the sixth cycle. Each member jurisdiction has been asked to decide whether it will commit to a multi-jurisdictional effort and to provide a decision by the subcommittee's upcoming January 12, 2022 meeting. Analysis of the advantages and disadvantages of the City's participation in a multi-jurisdictional housing element effort led staff to recommend a hybrid approach to participation. Under this scenario, if feasible, the City of Clovis would participate in certain defined components (such as regional needs and housing

assessments) of the multi-jurisdictional effort as a compliment to the work the City has already contracted with Ascent Environmental to perform. If this hybrid approach proves infeasible, staff is recommending that the City continue with an independent process as originally anticipated in its contract with Ascent.

BACKGROUND

As required by state law, each city and county must adopt a housing element as a mandatory element of their general plan. The housing element is required to be updated every eight years and is subject to detailed statutory requirements and mandatory review by the California Office of Housing and Community Development (HCD). Clovis' next housing element, the sixth cycle housing element, needs to be completed by September of 2023. This schedule is slightly ahead of HCD's mandatory timeline due to the requirements of the Local Early Access Program (LEAP) grant award the City received to cover the costs of the housing element preparation.

Before work typically begins on housing element preparation, the regional housing needs allocation (RHNA) must be calculated for each region by HCD, and then be allocated to individual jurisdictions. As this process relates to the City of Clovis, the HCD provides an overall housing figure for Fresno County, and FCOG is charged with working with local agencies and other stakeholders to allocate the County-wide totals to individual cities and the unincorporated county. This process also includes a further breakdown of the housing unit allocation by income group for each jurisdiction.

Sixth Cycle Housing Element Status – January 2022

The City of Clovis entered into an agreement with Ascent Environmental in January of 2021 to provide housing element-related services. The scope of work includes assisting the City with preparation of housing element annual reports as required by HCD, advising the City relative to the RHNA calculation methodology, and preparing the sixth cycle housing element. For City staff and Ascent team members, work over the last several months has focused on participating in the FCOG process of establishing a RHNA calculation methodology.

FCOG established a RHNA subcommittee comprised of 13 jurisdictions to deliberate on the methodology for allocation of each local government's fair share of the region's total housing need that was assigned by HCD. After several meetings, FCOG and the subcommittee recommended a proposed RHNA methodology for the Fresno County region for HCD's review. The proposed allocation methodology is currently under a 60-day review and will not be implemented until approval by HCD and final adoption by the FCOG Board of Directors.

The proposed allocation methodology includes three general steps. First, a base allocation factor is selected which is used to establish the initial allocation to each jurisdiction. Second, multiple adjustment factors are applied to account for conditions which tend to make jurisdictions more-or-less suitable for added housing. Finally, the units allocated to each jurisdiction are separated by income group using an "income shift" factor. The allocation methodology and process are summarized more thoroughly in Attachment 2. Based on the results of the process thus far, the preliminary RHNA calculations assign a total of 9,179 total units to Clovis, allocated as follows:

By comparison, the total allocation for the fifth cycle housing element (2016) was 6,328 units, and the total allocation for the fourth cycle housing element (2008) was 15,383 units.

While the final RHNA figures are pending, City Staff and the Ascent team have planned to commence work on the Clovis sixth cycle housing element at the end of January, 2022. The overall schedule may be affected by the Council's direction regarding participation in a multi-jurisdictional housing element, as discussed further below.

Multi-Jurisdictional Housing Element

A multi-jurisdictional housing element is a coordinated work product prepared by a single consulting team that covers the mandatory requirements applying to multiple agencies. Participating agencies are those that would otherwise each be required to prepare an individual housing element. Ultimately, the document must conform to applicable requirements for each participating agency as determined by HCD. Clovis' fifth cycle housing element was completed as part of a multi-jurisdictional housing element. Though staff explored the potential for a similar effort for the sixth cycle before contracting with Ascent, FCOG staff was unable at the time to confirm that a multi-jurisdictional effort would be pursued. It should be noted however, that the City's contract with Ascent anticipates the possibility of a regional effort and allows the City and the consultant to re-scope the project as may be necessary.

After interest was expressed by some cities during the fall of 2021, FCOG staff inquired as to each agency's interest in participating in a multi-jurisdictional effort. Jurisdictions were asked to provide a response at the upcoming subcommittee meeting to be held on January 12, 2022. With enough interest in participation, FCOG will take the necessary procedures to procure a qualified consultant to proceed with the work. A discussion of the potential advantages and disadvantages to participating in a multi-jurisdictional housing element is provided below.

Advantages of Participation in a Multi-jurisdictional Housing Element

One of the greatest benefits of participating in the multi-jurisdictional effort is the opportunity for a collaborative approach in identifying housing needs, constraints, and potential solutions. For example, rather than duplicating efforts between jurisdictions, one housing needs assessment could be conducted for all jurisdictions. In addition, a joint approach also provides strength in numbers during HCD review of the element. HCD may be more willing to accept a certain approach when applied by all jurisdictions rather than if the same approach was only applied by an individual jurisdiction. For example, a single regional fair housing assessment could be conducted along with individual local fair housing assessments that use a common approach and template. This may help to ensure a standard level of review for all jurisdictions.

New State law requirements to address fair housing are one of the greatest challenges for all jurisdictions in preparing the 6th cycle housing element. Although HCD has released guidance on addressing fair housing in the housing element, the required level of analysis continues to

change as HCD reviews each jurisdiction's housing element. Based on experience gained during the Sacramento Area Council of Governments housing element update process, the fair housing assessment is the greatest hold up in achieving housing element certification. Participating in a multi-jurisdictional may not only streamline the preparation of the fair housing assessment but may also allow for early HCD review and buyoff of the fair housing assessment. This would help to streamline HCD review of the housing element overall and provide greater confidence in expected housing element certification.

Another advantage is the opportunity for coordinated regional stakeholder engagement. Stakeholders are often the same for multiple jurisdictions. For example, housing developers in Clovis are likely the same as developers in the City of Fresno or the surrounding unincorporated county. Homeless service providers and non-profit affordable housing developers also cross jurisdictional lines. A joint stakeholder session could be conducted to gain knowledge on multiple jurisdictions, rather than each jurisdiction conducting their own outreach program.

Disadvantages of Participation in a Multi-Jurisdictional Housing Element

Although there are several benefits to participating in a multi-jurisdictional effort, there are also certain downsides that should be considered. One downside is the reduction in the City's autonomy during the process. The City would be one member of a greater committee and would have less control over consultant selection, community outreach, and scheduling. The City would need to work with the consultant selected by the committee, which may or may not be the City's preferred consultant. In addition, the City would likely receive less one-on-one consultant time as time would probably be shared amongst participating jurisdictions at committee meetings or be limited to certain office hours.

The City might also receive less specialized attention and certain nuances would likely be missed in the multi-jurisdictional effort. Rather than conducting an individualized community outreach program, outreach would be conducted at a regional level. As a result, the City may not gather as much insight or receive the same level of engagement from Clovis residents.

A multi-jurisdictional effort would likely result in a prolonged schedule compared to the schedule outlined in the City's agreement with Ascent. FCOG would need to first conduct a procurement process and would likely begin work in Summer 2022. This would slow down the City's community engagement process and would likely delay the City's target adoption date. As discussed previously, the City received LEAP funding to prepare the housing element update. LEAP funding must be spent by September 2023. Therefore, the City has targeted an adoption date of September 2023, rather than the State's adoption deadline of December 31, 2023. If the City chooses to participate in the multi-jurisdictional effort, the City will have less control over the schedule. The housing element update would likely be adopted after the City's September 2023 target date and may even fall into the State provided 120-day grace period which ends in April 2024.

FISCAL IMPACT

A streamlined multi-jurisdictional effort provides potential cost savings at a regional level. However, the cost savings for the City of Clovis as an individual jurisdiction are less clear. Under the City's agreement with Ascent, the cost for preparation of the housing element, HCD review,

community engagement, environmental compliance, and final documents and adoption is approximately \$170,000.

Under a rough cost estimate provided by FCOG, the proportion of cost identified as the City's responsibility totaled \$183,333. This included costs of \$50,000 beyond that of other smaller jurisdictions due to the size of Clovis. As such, the City would likely not attain any cost savings under the multi-jurisdictional effort, and if so, any savings would be nominal. In addition, it is important to note that the City already received LEAP grant funding that covers the cost of the housing element, so housing element costs will not impact the City's general fund.

REASON FOR RECOMMENDATION

As outlined above, there are both advantages and disadvantages of participating in the multi-jurisdictional effort. The City would likely benefit from participating in the multi-jurisdictional effort at a limited capacity that allows the City to gain certain benefits while avoiding drawbacks. The City could adopt its own independent housing element that incorporates the regional assessments, but would still allow the City to conduct its individual assessments and maintain control of the schedule. The City could commit to participating in a regional housing needs assessment and a fair housing assessment. These assessments would need to be completed early enough in the process for the City to move forward independently and meet its target adoption date. The community outreach program could be limited to regional stakeholder and early community engagement but allow the City to conduct its independent community workshop later in the process to receive community feedback on the public draft. This combined approach would allow the City to collaborate with fellow FCOG jurisdictions while still providing the City the independence needed to meet its own goals.

Unfortunately, the specific regional components that might be available to the City, their cost, and the timeline, are currently unknown. While it makes sense to utilize the regional information if it is available, participation in that manner should not risk delaying the adoption of the City's housing element and/or placing the City in non-conforming status. If partial participation in the multi-jurisdictional housing element is unfeasible, staff recommendation is for the City to proceed with a fully independent document.

ACTIONS FOLLOWING APPROVAL

If directed by the City Council, staff will seek partial participation in the FCOG's multi-jurisdictional housing element assessments and continue work on the City's independent housing element. If partial participation can be worked out, an agreement with FCOG will likely be required and the City's existing agreement with Ascent will need to be amended. Both actions would come back before the Council. If partial participation in the multi-jurisdictional housing element proves infeasible, no changes would be required since the City has a current agreement with Ascent that anticipates an independent process.

NOW, THEREFORE, BE IT RESOLVED, that the City of Clovis authorizes staff to pursue partial participation in the multi-jurisdictional sixth cycle housing element to include regional analyses and data components applicable to the City of Clovis Housing Element.

Overview of Proposed RHNA Allocation Methodology

During its monthly meetings from January to September 2021, the subcommittee deliberated on how to best allocate Fresno County's housing need to its jurisdictions. The final methodology as summarized below was divided into three general steps and was approved by the committee on September 23, 2021.

1. Determine a base allocation to establish the initial allocation for each jurisdiction.

The subcommittee was presented with a comprehensive list of datasets collected relating to the factors and objectives required to be considered as inputs to the RHNA methodology. These datasets are to be considered for creating the base allocation for the jurisdictions. FCOGs consultant, PlaceWorks, facilitated this process by providing necessary information and responding to comments and questions from members. Ultimately, the subcommittee voted to incorporate the following data layers as factors to create the base allocation. The factors were placed into an allocation tool that designates total units to each jurisdiction according to the selected factors. Clovis' established base allocation was 8,403 units.

- Projected growth
- Current population
- Exclude Sphere of Influence (SOI) area

2. Modify the base allocation to account for selected factors which make a jurisdiction more or less suitable for adding housing.

The subcommittee was tasked with choosing a preferred combination of adjustment factors and corresponding weights for each factor. The factors and weights would adjust the established base allocation to meet the goals or objectives of the region. These adjusted factors were placed into the allocation tool, which distributes housing units from the total regional determination to each jurisdiction according to the factors and their respective weights. Clovis' adjusted allocation per the selected factors and weights is 9,172 units.

3. Use the "income-shift" methodology to assign units by income tier.

The income-shift approach is an allocation based on four household income groups, including very low income, low income, moderate income, and above moderate income. This approach applies an adjustment factor of 100% or more, which determines the extent to which each jurisdiction's allocation of units by income tier will match the regional distribution for the current RHNA cycle or move all jurisdictions toward a more even distribution of units by income tier

overall. As the adjustment factor increases, each jurisdiction's allocation of units by income tier will change depending on how much higher or lower the jurisdiction's existing distribution of units in that income tier is, compared to the regional average. HCD recommends the adjustment factor be set to a minimum of 150%. The table below shows the individual jurisdiction's overall RHNA allocation by income tier.

On December 6, 2021, the Council provided consensus of the scope of the citizen's committee, determined the committee would be facilitated by a chair and vice-chair selected by the mayor, reviewed a draft timeline for committee meetings and received an analysis of expenditures and staffing within the Police Department for the past fifteen years.

Below staff has summarized (or will summarize at the meeting of December 6, 2021) the following four areas:

- a. Consensus direction provided to staff at the November 15, 2021 meeting.
- b. Options regarding facilitating the 25 member Committee through the process.
- c. Draft calendar for the Committee meeting timeline.
- d. An analysis of expenditures and staffing within the Police Department over the past fifteen years.

BACKGROUND

A - Confirm / amend consensus direction provided to staff at the November 15, 2021 meeting.

On November 15, 2021, the Council considered a request from former City of Clovis Police Chief Matt Basgall to discuss creating a Citizens' Advisory Committee for the purpose of evaluating police officer staffing. Significant discussion and feedback was provided to staff that evening regarding the request. Staff would like to confirm the consensus of the Council as follows:

1. Form the committee.
2. The makeup of the committee would be 25 members with each Council Member nominating 5 members each.
3. The scope of the Committee analysis would be staffing of the entire Police Department (compared to the Etico Solutions study which focused solely on Patrol staffing).
4. Review and report expenditures and staffing within the Police Department over the past fifteen years.
5. Consider what it is going to take to stay the "Safest City in the Valley".
6. Report back on the required timeline should a tax measure be considered to be placed on the November 2022 ballot.

In reviewing the audio of the meeting, staff would like to confirm two items that were discussed but unclear if there was a consensus as follows:

1. What is the consensus of Council participation on the committee? Will Council participate or not? And if so, in what capacity/frequency?
2. Unclear if Committee members would be required to live / work / own property in the City.
3. Council indicated they were interested in having members of the general public involved in the process, outside of the selected committee members. What type of involvement/participation would Council want from residents, not appointed to the committee, to have?

B - Consider options regarding facilitating the 25 member Committee through the process.

Staff is recommending that City Council consider how the Committee meetings will be facilitated. Facilitating a group of 25 members is going to be challenging. A partial list of options that Council may consider are as follows:

1. Hire an independent outside facilitator. Staff has done some research and has not been able to identify anyone who could act as a facilitator for this type of committee.
2. Select a chair and vice chair for the Committee and have those members act as facilitators.
3. Direct staff to facilitate.

C - Approve the draft calendar for the Committee meeting timeline.

Council was very clear that the Committee being formed was not a “sales tax committee”. That being said, one of the recommendations that the Committee could come back with is a need for additional revenues for the Police Department to add additional sworn officers. Should that be a recommendation, Council directed staff to look into calendar deadlines that would have to be met for the November 2022 to add a tax measure to the ballot.

For election purposes, the November 8, 2022, election is considered a statewide election. When a city calls for an election on a municipal proposition, such as a local tax measure, to be held on the same date and consolidated with a statewide election, the City Council must approve a resolution calling for the election; requesting the municipal election be consolidated with the statewide election; and include the exact form of the question/proposition as it would appear on the ballot. The approved resolution must be filed/submitted with the county at least 88 days prior to the date of the election. The different types of taxes (sales tax, parcel tax, transient occupancy tax, etc.) and whether the tax is general or special does not impact this 88-day deadline. Along with the approval of the resolution, an ordinance imposing the proposed tax (subject to voter approval) is introduced.

Looking ahead at the calendar of City Council meeting dates, Monday, August 8, 2022, is 92 days before the November 8, 2022 election. The resolution calling for the election and approving the ballot measure text would need to be approved no later than August 8, 2022, and then the approved resolution submitted to the Fresno County Clerk/Registrar of Voters no later than Friday, August 12, 2022, to get the measure on the November 8, 2022 ballot. Staff would recommend an earlier date for Council consideration to allow some flexibility should additional time be needed. An earlier Council meeting date could be selected, but August 8, 2022 is the last possible Council meeting date to qualify for the November 8 election. Please recall that Council traditionally goes on recess in August and conducts only the first meeting, which would be August 1, 2022.

Possible calendar for the Committee may be as follows:

- January – April 2022 – two meetings per month on the 2nd and 4th Wednesdays for a total of 8 meetings.
- May 2022 Committee reports back to Council on results of analysis and recommendations.
- June 2022 – Town hall meeting(s) for Council to consider results of analysis and recommendations.
- July 2022 – If Council direction is to place a tax measure on the ballot, there are other administrative matters and deadlines the City Attorney and City Clerk will need to complete with regard to preparing and submitting an impartial analysis and a synopsis of the measure and handling any arguments in favor or against the measure so that they all get sent to the County Clerk/Registrar in time to be included in the voter pamphlet.
- August 8, 2022 – deadline.

D - Receive and File an update on expenditures and staffing within the Police Department over the past fifteen years.

The Finance Department is in the process of completing an analysis of expenditures and staffing in the Police Department between 2005/06 and 2019/20. A copy will be provided to City Council at the meeting on Monday, December 6, 2021.

Attachment 2 is the staff report that went to Council on November 13, 2007 that summarizes the recommendations provided to Council by the Committee. The report is provided as background information for Council for what a similar Committee analyzed between 2007 and 2008.

Ideally, Council would provide the names of their five candidates in time to have the Committee approved by Council at the December 13, 2021 meeting. Staff is currently recommending cancelling the Council meeting of December 20, 2021 as it falls on the week of a holiday. Should we not have the Committee formed until January, it could possibly delay when the Committee could begin to meet.

The venue of where the Committee meetings will be held needs to be determined and how they are conducted. The size and technical configuration of the Council Chamber is not conducive to a 25 member Committee to participate and allow for video broadcasting, such as Council Meetings are done today. One alternative that staff is considering is to select a venue such as the Emergency Operations Center (EOC) or the Senior Center, and have CMAC broadcast the meeting. The meetings would be open to the public. The video broadcasting would not allow for what we have in the Council Chambers today via Webex and two-way communication. Residents who wanted to participate in the meetings would be required to attend.

FISCAL IMPACT

At this point there is no significant impact on the budget in reviewing what is being considered in this report. If Council directs staff to find an outside facilitator, there will be costs incurred. Additionally, if the City uses CMAC to broadcast the video, there will be costs incurred.

REASON FOR RECOMMENDATION

At the November 15, 2021 Council meeting, Council provided direction to return to Council regarding the development of a Citizens' Advisory Committee to provide an analysis of expenditures and staffing within the Police Department over the past fifteen years.

ACTIONS FOLLOWING APPROVAL

RECOMMENDATION

For the City Council to provide direction to staff based on the request from Matt Basgall. If the direction is to form a committee staff would be looking for direction on the number and criteria to be used for selecting membership, as well as the scope of the committee's work and expected timeline.

EXECUTIVE SUMMARY

Staff is in receipt of a request to the Clovis City Council from former City of Clovis Police Chief Matt Basgall. The request is for the City Council to discuss creating a citizens advisory committee for the purpose of evaluating police officer staffing.

BACKGROUND

As detailed in the Police Department Staffing Study that was presented to Council on November 8, the number of sworn officers that is currently funded is well below the Department's goals. Due to the limitations on staffing, the Police Department has had to reduce or eliminate various services. In response to this situation, former Police Chief and current Clovis resident, Matt Basgall, has submitted a letter requesting that Council establish a Citizen's Advisory Committee to analyze the staffing needs for the Police Department, to provide feedback to the Council regarding what the citizens of Clovis expect from the Department, and to examine funding options to meet those expectations.

A similar Citizens Advisory Committee was established by the Clovis City Council in 2007. For reference, the following is a brief background on that process and outcome: Between April and June 2007 the City Council conducted workshops on future funding for services for Police, Fire, Street Maintenance, and Park Maintenance. By June 2007 the City Council had appointed 15 members (three each) of the public to participate on a Citizens Advisory Committee to evaluate future funding for services for Police, Fire, Street Maintenance, and Park Maintenance. The Committee met twice monthly from June through September 2007. As part of the process the city also retained a consultant to evaluate the benefits of the 1999 Measure A sales tax override and to prepare a survey to gauge the public support for a potential sales tax measure to follow the 1999 Measure A. In December 2008 the Clovis City Council adopted Ordinance 08-27 to enact a one cent sales tax for ten years and a three quarters of a cent thereafter for restoration and protection of essential city services and calling a March 2009 election for the voters to consider. The measure was a general tax and as such required a simple majority for adoption. The measure failed 68% to 32%.

Staff is currently seeking direction from Council regarding the potential establishment of Citizens Advisory Committee as requested by Matt Basgall. If Council decides to establish such a committee, specific direction would be needed regarding the make-up of the committee, the scope of the analyses that they will conduct, and the timeline for providing feedback to Council.

FISCAL IMPACT

At this point in the discussion there is no fiscal impact. Depending on Council's direction, there could be costs for additional studies or surveys to support the committee's work. The cost of any such studies would be expected to be similar in magnitude to the recently completed staffing study, and funding is available for studies of that order.

REASON FOR RECOMMENDATION

SUBJECT: Citizen Advisory Committee

This is a request to discuss a citizens advisory committee for the purpose of police officer staffing levels in the City of Clovis. The Clovis Police Department has been working understaffed since the recession of 2008. Over the past 13 years Clovis PD has seen a significant increase in both residents, businesses and hotels. In 2007-2008 the Clovis Police Department was authorized to be at 116 officers and a commitment to keep officers at a ratio of 1.3 officers per 1000 residents. As a result of the recession Clovis PD was cut to 91 officers. Currently the authorized number is 109. With a population of approximately 125,000 this gives a ratio of .87 officers per 1000 residents.

Since the Police Department relies solely on the general fund the staffing is at the mercy of those revenues. Over the past 13 years we have seen a recession, increase in retirement costs and COVID dramatically impact the police departments ability to grow with the city. The question is what will be the next thing that impacts the city and public safety.

Clovis Police Department has always prided itself on its community support and being a full-service department. With the current environment these commitments are strained and becoming unreasonable to meet. The Police Department relies on volunteers for muni-code enforcement. However with COVID many volunteers have chosen to not return to the PD.

GOALS OF COMMITTEE

Analyze staffing needs for the Police Department

- 1) Provide feedback to the City Council
- 2) Establish what the citizens of Clovis want and expect from Clovis PD
- 3) Examine funding options

QUESTIONS FOR COUNCIL:

- 1) Does the council want to participate in a workshop
- 2) Does council want to appoint members onto the committee
- 3) How many persons should be involved in the process

Clovis Police Department is in process of having a study completed to examine the needs of the department, which will be provided to the Council. The Clovis Police Officers Association has agreed to fund a survey to be sent to the citizens of Clovis that will address the hard questions. What are the citizens willing to pay for safety. What are they willing to give up and what do they want from their police department.
